Fr. Soly has also established teams for blind football, wheelchair basketball, and cricket, all of which have competed at high levels and won numerous accolades. The Dharsana Chess Tournament is now a prestigious event, producing national and international champions. Additionally, he founded the Sports Association for the Differently Abled of Thrissur (SADAT) to promote Paralympic sports.

Fr. Soly's commitment extends beyond sports. He has initiated programs like the Para Athletic Meet, annual wheelchair distributions, and the "Blood for Life" campaign. His efforts have led to the construction of 12 houses for differently-abled families, with more underway. The Dharsana YouTube Channel, with thousands of subscribers, showcases the talents and stories of people with special needs.

His work in counselling and spiritual animation in prisons, as well as his roles at the Navjeeavan Project and Amala Institute of Medical Science, further highlight his dedication to holistic support. Regular programs like "Snehasangamam," solidarity groups, skill training, financial support for education and medical treatment, and various competitions and celebrations are testament to his tireless efforts to uplift the differently-abled community.
